### Part 1 - Attend and vote in person

#### Attend and vote in person at **The Capital, 50 View Street,** Bendigo, Victoria 3550

In person registrations will start at 10am (AEDT) on Tuesday, 8 November 2022.

#### Travelling by car

Estimated travelling time from Melbourne CBD to Bendigo is 1 hour 40 minutes via the Calder Freeway (M79).

#### Parking

There is plenty of public parking near The Capital. Off-street (ticketed) car parking is available at the Rosalind Park car park, behind the Capital Theatre and the Bendigo Gallery. Entry is at View and Rowan streets.

#### Travelling by train

The Melbourne to Bendigo V/Line express train service takes you to the Bendigo Railway Station, which is approximately a 15 minute walk to The Capital.

### Part 2 - Attend and vote virtually

Join at https://web.lumiagm.com/309859902 using any web browser on a computer, tablet or smartphone device (using the latest version of Chrome, Safari, Internet Explorer 11, Edge or Firefox).

Online registration will open at 10am (AEDT) on Tuesday, 8 November 2022.

\* If you have received more than one Direct Voting / Proxy Form for different shareholdings then you will need to log in separately for each holding using the corresponding Voting Access Code and postcode on the Direct Voting / Proxy Form in order to vote during the virtual AGM.

#### 1. Getting Started

- a. To join the virtual meeting, you will need to enter the unique 9-digit Meeting ID 309 859 902 and select 'Join'. To proceed to registration, you will be asked to read and accept the Terms and Conditions.
- b. If you are a Shareholder, select 'I have a login' and enter your Username and Password.
- c. If you are a Proxy holder, attorney or corporate representative you will need to enter the unique Username and Password provided by Boardroom prior to the meeting and select 'Login'.
- d. If you are not a Shareholder, select 'I am a guest'. You will be asked to enter your name and email details, then select 'Enter'. Please note guests are not able to vote or ask questions at the AGM.

#### 2. Navigating

- Once you have registered, you will be taken to the homepage which displays your name and the AGM information.
- b. To activate the webcast, please click on the Broadcast bar at the bottom of the screen. If prompted you may have to click the play button in the window to initiate the broadcast.
- c. Once you select to view the broadcast it can take up to approximately 30 seconds for the live feed to appear on some devices. If you attempt to login before the AGM commences, a dialog box will appear until the meeting does commence.
- d. It is recommended that once you have logged in, you keep your browser open for the duration of the AGM. If you close your browser you will be asked to repeat the log in process.

#### 3. To ask a Question

#### Written questions

- a. Select the question icon at the top of the screen 📃
- b. Compose your question as concisely as possible.
- c. Select the send icon 🕨
- d. You will receive confirmation that your question has been received.

#### Oral questions

- a. Pause the meeting broadcast and select 'Asking audio questions'.
- b. Enter your name and the topic of the question.
- c. You will be placed into a virtual queue. You will be able to listen to the live audio from the meeting.
- d. When it is your turn, your name will be read out by the moderator, and you will be asked to proceed to ask your question.
- e. After you have asked your question, hang up, and return to the Lumi platform.

#### 4. To Vote

- a. When the Chair declares the polls open, select the voting icon at the top of the screen and the resolutions and voting choices will appear.
- b. Press the option corresponding with the way in which you wish to vote.
- c. Once the option has been selected, the vote will appear in blue.
- d. If you wish to change your vote, you can simply press the new vote option or cancel your vote at any time before the Chair closes the polls.
- e. Upon conclusion of the AGM the home screen will be updated to state that the meeting is now closed.

# 5. Auslan sign-language and script at bottom of screen

An Auslan interpreter will be available on-screen for the duration of the meeting, and closed captioning will also be available for the Chair's and Managing Director's speeches.
